1. General

- 1.1 These terms apply to all visitors of our website.

2. Definitions

- 2.5 By “content” we mean data, text, information, screen names, graphics, photos, profiles, software, music, files, sounds, static and mobile images.

- 2.7 By “visitor” we mean any person viewing our website.
- 2.8 By “our serviced countries” we mean the United Kingdom, Isle of Man and the Channel Islands.

8. 14.3 Notice will be deemed received and properly served immediately when posted on our website, 24 hours after an email is sent, or 3 days after the date of posting of any letter.

14.4 In proving the service of any notice, it will be sufficient to prove, in the case of a letter, that such letter was properly addressed, stamped and placed in the post and, in the case of an email, that such email was sent to the specified email address of the addressee.

15. Transfer Of Rights And Obligations

15.1 The contract between you and us is binding on you and us and on our respective successors and assigns.

15.2 You may not transfer, assign, charge or otherwise dispose of a contract, or any of your rights or obligations arising under it, without our prior written consent.

15.3 We may transfer, assign, charge, sub-contract or otherwise dispose of a contract, or any of our rights or obligations arising under it, at any time during the term of the contract.

16. Events Outside Our Control

16.1 We will not be liable or responsible for any failure to perform, or delay in performance of, any of our obligations under these terms that are caused by events outside our reasonable control (force majeure event).

16.2 A force majeure event includes any act, event, non-occurrence, omission or accident beyond our reasonable control which prevents performance of our obligations and includes, in particular, without limitation, the following:

16.2.1 Third party strikes, lock-outs or other industrial action;

16.2.2 Civil commotion, riot, invasion, terrorist attack or threat of terrorist attack, war (whether declared or not) or threat or preparation for war;

16.2.3 Fire, explosion, storm, flood, earthquake, subsidence, epidemic or other natural disaster;

16.2.4 Impossibility of the use of railways, shipping, aircraft, motor transport or other means of public or private transport;

16.2.5 Impossibility of the use of public or private telecommunications networks;

16.2.6 The acts, decrees, legislation, regulations or restrictions of any government.

16.3 Our obligations under these terms are suspended for the period that the force majeure event continues, and we will extend the time to perform these obligations for the duration of that period.

16.4 We will take reasonable steps to limit the effects of the force majeure event or to find a solution by which our obligations under these terms can be performed despite the force majeure event.

17. Waiver

17.1 If we fail, at any time during the term of a contract, to insist upon strict performance of any of your obligations under the contract, or if we fail to exercise any of the rights or remedies to which we are entitled under the contract, this shall not constitute a waiver of such rights or remedies and shall not relieve you from compliance with such obligations. A waiver by us of a particular default shall not constitute a waiver of any other default. No waiver by us of any of these terms shall be effective unless it is expressly stated to be a waiver and is in writing.

18. Severability

18.1 If any terms, conditions or provisions of a contract are invalid, unlawful or unenforceable to any extent, such term, condition or provision will to that extent be severed from the remaining terms, conditions and provisions which will continue to be valid to the fullest extent permitted by law.



19. Entire Agreement

19.1 These terms and any document expressly referred to in them are the entire agreement between you and us in relation to your use of our website and supersede any prior agreement, understanding or arrangement between us, whether oral or in writing.

20. Variations

20.1 We have the right to revise and amend these General Terms from time to time. You will be notified of any revisions or amendments. We will post a new version of them on our website.

20.2 If you object to any new General Terms then you must stop using our website immediately.

20.3 Some of the provisions contained in these General Terms may also be superseded by provisions or notices published elsewhere on our website.

21. Third Party Rights

21.1 A person who is not a party to this contract has no rights under the Contracts (Rights of Third Parties) Act 1999 to enforce or benefit from any term of this contract but this does not affect any right or remedy of a third party which exists, or is available, apart from that Act.

21.1 The rights of the parties to terminate, rescind or agree any variation, waiver or settlement of these terms is not subject to the consent of any person that is not a party to this contract.

22. Law And Jurisdiction

22.1 English law will apply to:

22.1.1 These terms;

22.1.2 Any dispute or claim arising out of or in connection with these terms or their subject matter or formation (including non-contractual disputes or claims).

22.2 Any dispute or claim arising out of or in connection with our contract (including non-contractual disputes or claims) shall be subject to the non-exclusive jurisdiction of the courts of England and Wales.
